
With the reducing number of Mutuals, Australian Mutuals History is in need of additional funding in order to maintain our services. Australian Mutuals History would value donations

Best of the Blog Australasian Mutuals Institute: Instilling Confidence



On 5th March 2020, the Australasian Mutuals Institute (trading as Instil) closed its doors after almost 40 years educating mutual finance professionals. For most of those 40 years, it was known as the Australian Institute of Credit Union Management (AICUM). To a large extent the brainchild of Graham Humphreys, it was beloved for its annual convention held in Albury (site of the 1994 convention picture above).
